Treasurer's Report

There is some confusion with the insurance payment. Dan got a thank you note for renewing and Bob got a cancellation notice. Bob states that the bill has been paid. Dan will follow up on this and make sure the payment has been received and posted correctly.

Invoices were sent out for dues. Invoices were not sent out to Board Members at this time. Bob will wait until after the election on June 26 to see who will be the 2011-2012 new board members. First offence: Make a call to the parents and make them aware of the rules.

2nd offence: Suspend the family swimming privilege for 2 weeks

3rd offence: Revoke swimming privileges for the family for the rest of the swimming year

Life guards are keeping notes daily on activity in the pool.

Monitoring who swims every day.

Computer report on the gate is not accurate. Leigh Ann will notify Anchor Fence and will work with them on getting the reports accurate.

Fox Hollow residents want to pay some dues and use the pool. The decision was not to allow this at this time.
