Treasurer's Report given by B. Unland

- 1. Copies of the Financial Report were passed out and reviewed.

- 5. A. Cummings to report solely to J. Welker.
- 6. Per security footage, L. Owen vouches to his good work with a few issues to be addressed. Mainly, evening arrival time & mopping the bathroom floors.
- 7. J. Welker calling Doug's Pool to check on any issues with shocking the pool.
- 8. Motion to look into A. Cummings shocking the pool by T. Mast, 2nd by J. Stroupe. Motion passed unanimously.
- 9. B. Unland created a task list for opening of the pool, of which much was left undone. He will send list to H. Ward to forward to board so we can split the duties.
- 10. Motion by H. Ward to repair chairs and loungers for an amount up to \$800 at business for quote provided by L. Owen, 2nd by L. Owen. Motion passed unanimously.

It became apparent that much was discussed with non-board members after the last closed session, and this has caused undue stress for others involved in the closed session.
